AGREEMENT

- Automatic Delivery - The company agrees to make timely deliveries as long as the account is current. It insures emergency deliveries in case of accidental run out.
- Budget account - All payments are due the 20th of each month. A .10 per gallon discount will be applied to account at the time of each delivery. If this account becomes delinquent, deliveries cease and the account becomes due and payable in 30 days and is subject to all finance charges.
- Charge account - Payments are due net/ 30 days from the billing date. Any discounts are based on payment within 10 days.

All oil deliveries and burner service charges are due 30 days from billing date. Failure to make payment in 30 days will resulting your account being subject to finance charge equal to 1.5% per month on the unpaid balance (18% per annum). In the event that your account is placed in for collection, you will be liable for any and all legal and court costs. The parties agree that should litigation take place relative to enforcement of this agreement the General District Court and Circuit Court of the City of Chesapeake will be the Courts of Executive Jurisdiction.
